# **Food Truck Vendor Agreement**

This agreement is made between Oklahoma Latin Pride, Inc. (OKLP) ('Event Organizer') and the undersigned Food Truck Vendor ('Vendor') for participation in the OKLP celebration event.

By signing this agreement, the Vendor agrees to abide by the following Terms and Conditions:

#### 1. Participation Fee

Vendor agrees to pay a non-refundable vendor fee as provided on the website upon registration confirmation. Space will not be guaranteed until payment is received in full.

# 2. Setup & Operation

Arrival & Setup Time: An email will be sent out closer to the event.

Breakdown Time: An email will be sent out closer to the event

All food trucks must comply with Oklahoma City and Oklahoma County Health Department regulations.

#### 3. Power & Generator Policy

Power and Water: The Event Organizer does not guarantee the availability of power or water at the event site.

Generator Requirement: Vendors must bring their own power source.

- Preferred Generator Type: Inverter generator (for lower noise and emissions).
- Other Generator Types: Acceptable, but must not pose safety or noise concerns.
- Questions about generator specifications should be directed to the event coordinator.

#### 4. Representation & Warranties

Both parties represent that:

- They are fully authorized to enter this agreement;
- They have the expertise and capability to perform their obligations;
- Their actions do not infringe upon any third-party rights or violate any existing contracts, laws, or regulations.

#### 5. Health & Safety

Vendors are responsible for maintaining cleanliness, including disposing of all waste at the end of the event.

All staff must adhere to food safety guidelines and maintain a professional appearance and conduct.

## 6. Liability Waiver

Under no circumstances will either party be liable for indirect, special, consequential, or punitive damages (including lost profits) related to this Agreement.

Each party holds the other harmless from claims, damages, or losses resulting from the negligence or misconduct of their employees or representatives.

OKLP is not responsible for lost, stolen, or damaged items during the event.

## 7. Cancellation & Refund Policy

All vendor fees are non-refundable. No refunds will be issued under any circumstances, including vendor cancellation or no-shows.

The Event Organizer reserves the right to cancel the event due to weather, safety, or unforeseen circumstances. If canceled by the organizer, a partial or full refund may be issued at their sole discretion.

#### 8. Governing Law

This Agreement shall be governed by and interpreted under the laws of the State of Oklahoma.
