Community Zone Agreement

Oklahoma Latin Pride (OKLP) – Community Zone Vendor Agreement

Organization: Oklahoma Latin Pride, Inc. (OKLP)

This agreement is made between Oklahoma Latin Pride, Inc. (OKLP) ('Event Organizer') and the undersigned Community Zone Vendor ('Vendor') for participation in the OKLP celebration event.

By signing this agreement, the Vendor agrees to abide by the following Terms and Conditions:

1. Participation Fee

Vendor agrees to pay a non-refundable vendor fee as provided on the website upon registration confirmation. Space will not be guaranteed until payment is received in full.

2. Setup & Operation

- **Arrival & Setup Time:** An email will be sent out closer to the event.
- **Breakdown Time:** An email will be sent out closer to the event.
- All vendors must comply with applicable Oklahoma City and Oklahoma County regulations.

3. Presence & Duration

The Vendor agrees to maintain their presence at their designated space for the entire duration of the event, from the official opening to the official closing. Early breakdown or departure is strictly prohibited. Failure to adhere to this commitment may result in the Vendor not being invited to participate in future OKLP events.

4. Recording and Media

The Event Organizer may record all or part of the Vendor's presence and activities at the event. The Vendor grants the Event Organizer the right to use and publish the Vendor's

name and photographs for advertising purposes in connection with the Event and future event promotion. The Event Organizer may begin promoting the Event on the day of the event or when the Agreement is signed.

5. Representation & Warranties

Both parties represent that:

- They are fully authorized to enter this agreement.
- They have the expertise and capability to perform their obligations.
- Their actions do not infringe upon any third-party rights or violate any existing contracts, laws, or regulations.

6. Health & Safety

Vendors are responsible for maintaining cleanliness, including disposing of all waste at the end of the event. All staff must maintain a professional appearance and conduct.

7. Liability Waiver

Under no circumstances will either party be liable for indirect, special, consequential, or punitive damages (including lost profits)¹ related to this Agreement. Each party holds the other harmless from claims, damages, or losses resulting from the negligence or misconduct of their employees or representatives. OKLP is not responsible for lost, stolen, or damaged items during the event.

8. Cancellation & Refund Policy

All vendor fees are non-refundable. No refunds will be issued under any circumstances, including vendor cancellation or no-shows. The Event Organizer reserves the right to cancel the event due to weather, safety, or unforeseen circumstances. If canceled by the organizer, a partial or full refund may be issued at their sole discretion.

9. Governing Law

This Agreement shall be governed by and interpreted under the laws of the State of Oklahoma.
